2011 Portland Swap Meet Rules

The Portland Swap Meet LLC, its associated committee(s) or authorities, reserves the right to exclude or reject without recourse any person or items which violate the following rules, or are otherwise deemed objectionable.

- 1. ONLY AUTO-RELATED ITEMS ARE ACCEPTABLE in the regular Swap Meet stalls. Approved items include: hard car parts, metal, rubber, leather, wood, replacement kits; automotive literature; Automobilia and/or gasoline memorabilia over 20 years old; vintage clothing, accessories & jewelry over 30 years old; auto restoration products; and vehicles for sale. (Contemporary automobilia, collectibles, novelties, bicycles, pins, or transportation toys mfg'd within the last 20 years must be in an Antique/Collectible stall.)
- 2. Raffles are NOT allowed.
- "Cars for Sale" must be 1980 or older and MUST REMAIN IN THEIR ASSIGNED STALL DURING REGULAR VENDING HOURS.
- 4. All vehicles entering the Swap Meet grounds, whether unloading parts or "Cars for Sale," must display a rearview mirror hanger or they will be subject to towing at owner's expense. THERE WILL BE NO VEHICULAR MOVEMENT DURING THE GENERAL ADMISSION HOURS OF THE SWAP MEET FRIDAY FROM 7AM TO 7PM, SATURDAY FROM 7AM 5PM, AND SUNDAY FROM 8AM TO 1PM.
- Each vendor stall must be utilized for the purpose of selling; otherwise the stall may be cleared and resold."PARKING ONLY" IS NOT ALLOWED and vehicles will be towed and impounded at owner's expense.
- Except for the HALL B cars for sale area, there will be no assembled, motorized vehicles of any kind allowed "For Sale" inside any building. Absolutely no motorized vehicles, including motorcycles/bikes, are allowed inside any other building during the Swap Meet. (Fri. 7 AM to Sun. 1 PM.)
- 7. FIRE MARSHALL REGULATIONS: (The Fire Marshall will be enforcing the following)
 - No "flammable gas, liquid or solid" is allowed to be sold. Likewise, portable gas, nitrous tanks, or electric cooking devices or heaters are not allowed inside any Swap Meet building.
 - Any outside vendor with an acetylene tank, propane tank, BBQ grill, heating or cooking devices must have a 10 BC type fire extinguisher visible and in good working order.
- 8. Roller skates, rollerblades, skateboards, bicycles, scooters or motorized conveyances are not allowed.
- 9. Pets are not allowed on the Swap Meet grounds at any time.
- 10. T-Shirt Rule: Vendors may display one (1) T-Shirt per stall, advertising their company and/or products, (i.e. 3 stalls = 3 shirts) and representing stock kept under the counter and not otherwise visible.
- 11. Only non-motorized wagons and carts for hire that do not exceed 2 ft. wide by 3 ft. long will be allowed.
- 12. There will be no camping overnight inside the fenced Swap Meet area.
- 13. Vendors must stay within the boundaries of their stall to comply with fire lanes.
- 14. ANYONE IN VIOLATION OF ANY OF THESE SWAP MEET RULES WILL LOSE THE PRIVILEGE OF PRE-REGISTRATION FOR THE 2012 PORTLAND SWAP MEET.

Message to Vendors

It is our goal to make this the best "Antique & Collector Car" Swap Meet in the nation...We ask for your cooperation and compliance with our rules and the following guidelines:

- NOTE: NO VENDOR DELIVERY'S WILL BE ACCEPTED AT THE PORTLAND EXPO CENTER PRIOR TO MARCH 29, 2011.
- Vendors are required to wear their Vendor Badges in plain sight at all times during the Swap Meet.
- Stalls are not to be sublet or re-sold by Vendors. If you need to cancel prior to the Swap Meet, please call our office: 503-678-2100.
- Thursday is a Vendor Set-Up day 8 AM to 8 PM Vendor badge must be worn at all times during set-up. There
 will be no General Admission on Thursday. 3-Day passes will be available for sale on Thursday only.
- · After setting up your stall(s), please cover all items with a tarp or black plastic when you leave for the day.
- · Vendors will be admitted one hour earlier than the posted opening hours each day during the Swap Meet.
- Stalls must be manned from opening hour to closing each day. (The Swap Meet closes at 1 PM on Sunday, and the Committee expects each Vendor to remain set-up and selling until that time.)
- Amplified speaker systems and unmuffled engines are not allowed.
- Helium balloons or other free-floating devices are banned inside the buildings.
- Reservation applications will be accepted until March 1, 2011; cancellation and refund requests will be accepted until March 15, 2011.
- Please read and abide by the Portland Swap Meet "Rules" and note the following list of unacceptable items: Food or beverages for sale, craft items, utility trailers, boats, chainsaw statues, wood stoves, personalized license plate frames, stuffed animals, pillows, T-Shirts and other clothing, nametags, caps, cowboy hats, sunglasses, modern or contemporary items such as ceramics, video or sound tapes, wooden toys, plants, posters, switchblade knives, guns, pornography, Beanie Babies, or any other items deemed unacceptable by the Portland Swap Meet Committee.
